Margaret Hummert Howe, Class of 1958, was involved in a variety of classroom and extra-curricular activities while at Mater Dei, including class officer, Em-Dee, Pep Club, CYO

officer, May Queen Attendant, Catholic Literature Award, I.H.S.A. Award, Music Festival, Glee Club Accompanist, Student Librarian, Music, Sodality, and Dramatics.

Thanks to her teachers at Mater Dei Margaret was able to pursue a teaching career and credits her life long interest in the piano and music to Sr. Rose de Lima (now Harriet Suppan). During her years at Mater Dei Margaret was given the opportunity to get involved in producing the school newspaper and taking part in school plays, both of which were helpful in her later work

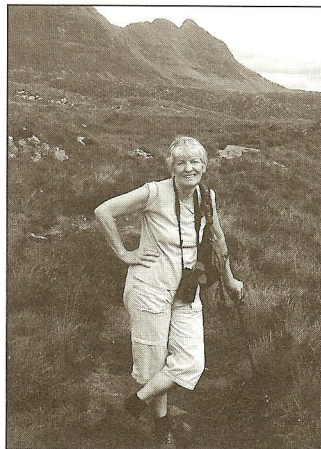
producing inset programs, initiating literacy projects, and making public presentations. After moving to England with her husband in 1970, Margaret continued teaching and worked with a Literacy Support Service as a Literary Consultant. Later in her career Margaret used her musical talents to organize and train a children's music group at the Catholic church in which she attended and accompany music groups at the schools where she taught. As a lector and Sunday school teacher, Margaret has been involved in her Catholic parish for many years.

Although retired, Margaret is still involved in the school at which she last taught, supporting a project she set up three years ago

with a grant that involves 8 to 11 year olds taking books home to share with their pre-school siblings, cousins, or neighbors.

Margaret is a volunteer and on the management committee of Home-Start, a charity which supports mothers, many who have suffered from post-natal depression. Also, Margaret has been busy helping a legally blind friend with a research project, assisting with typing and reading articles and other professional materials.

Pope John Paul II once stated, "Catholic schools have proven to be of priceless value to generations of children, teaching them to know, love and serve God, and preparing them to take their place with responsibility in the community." Margaret Hummert Howe is a shining example of this statement and of how she lives the mission of Mater Dei throughout her life.

I didn't understand the real meaning of Mater Dei until I began my own journey down her halls and into her classrooms. Little did I realize that this was only the start.

This journey took shape and form over the next four years. This can be credited to the countless number of teachers both lay and religious and the administration that dedicated their lives to developing a path of faith. I opened my eyes and saw God's "special" children at Mur-ray Center in Centralia; I opened my ears and heard the voice of God through music. Those who believed deeply in Jesus surrounded me.

Four years went by all too quickly and this faith journey became my own as I was guided into my life-long ministry of Nursing. Nursing became an extension of what I had "seen and heard." I never doubted this path I was given. I learned to comfort those who were dying, encourage those who were giving birth, and to be joyful with those

who were healed.

God continued his loving guidance to keep me along his path, in spite of worldly dreams to big cities far away. My real journey took a different path, however, when I married Jim Darr in November of 1976 and Catholic education became an important part of our life. We had grown from Catholic backgrounds and were strengthened by our common values and traditions. This bond of faith was to be truly tested during the summer of 1989, as I questioned does God love me?

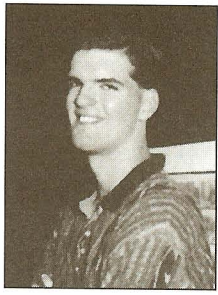
July began with the accidental death of my brother, Tom Koch, '78. I chose to can-tor at his funeral the morning of July 14 and the consoling words were sung, "Eye has not seen, ear has not heard what God has ready for those who love him..." But was I really ready to LOVE him? I had no idea I would be answering this question in only a few short hours. The answer I found

was, "You have no other choice because it is in his footsteps we are carried." I was truly carried by God, because five hours later, our 7-year-old son Ryan was killed. Yes, God loves those who love him. Jim and I found the courage to let Ryan go to him. We truly believe God's promise of eternal life. We had the gift of our faith!

The understanding of faith, hope, and love have been carefully chosen for us. My journey is not finished. I know my Catholic education at Mater Dei has directed me to become the person I am trying to become.

Dr. Jeff Ripperda has spent most of his life making a difference in the world. In high school, Jeff was involved in almost every aspect of our school. Throughout his college years, Jeff participated in various community and service groups and traveled to Spain and other European countries. Now, as Jeff prepares to finish his residency at the Family Medical Center in Peoria, he continues to make a difference.

The activities in which Jeff was involved included Energynet, the Knight, the Lance, Scholar Bowl, Liturgical Music Group, Chorus, the Fall Play and Spring Musical. Jeff was also selected as an Illinois State Scholar, was active in the National Honor Society, and graduated as Valedictorian of the Class of 1996 and was voted Knight of the Year. Outside of school, Jeff served his home parish of St. Bernard, Albers, as a lector and Eucharistic minister. He was also named Outstanding Catholic Youth by the Diocese of Belleville.

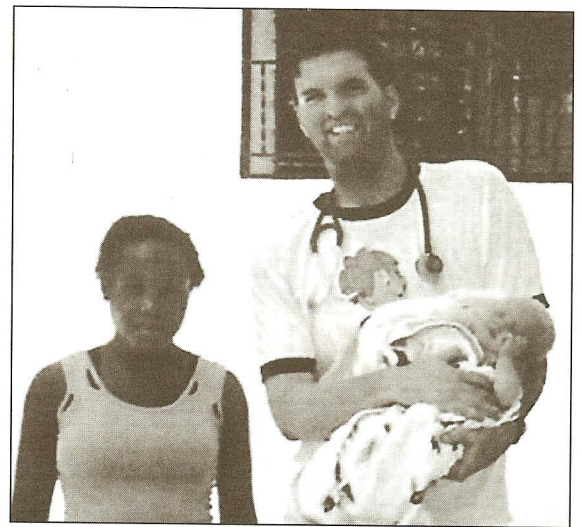
Dr. Ripperda moved on to attend Knox College in Galesburg, Illinois, and graduated in 2000 with a degree in Spanish and Biochemistry. While at Knox, Jeff was vice-president of the service fraternity Alpha Phi Omega and through this organization, coordinated various projects for numerous local organizations, including the American Red Cross, Habitat for Humanity, and the Galesburg Masson, a shelter for battered women.

After graduating from Knox, Jeff was accepted to the University of Illinois School of Medicine in Rockford, Illinois. Jeff graduated in 2004 and moved to Peoria to continue training at the University of Illinois' Family Practice Residency. Jeff is in his final year of residency and is currently interviewing with various hospitals in Southern Illinois for a position in July 2007.

Jeff and his wife, Kate (Wiegman), '96, have volunteered hundreds of hours to those in need. Throughout the summer of 2001, Jeff and Kate

worked in Mexico, volunteering with the Fundacion El Puente de Esperanza (the Bridge of Hope Foundation). Jeff is currently involved with the Friends of the Children of Haiti (FOTCOH), an organization in Peoria that owns a clinic in Haiti, where Jeff spent two weeks with a team of 17 volunteers providing free medical care. Jeff credits the experience he received at Mater Dei, especially the Spanish background, for his continued involvement with helping others.

Jeff and Kate are also the proud parents of a three-year-old daughter named Greta.

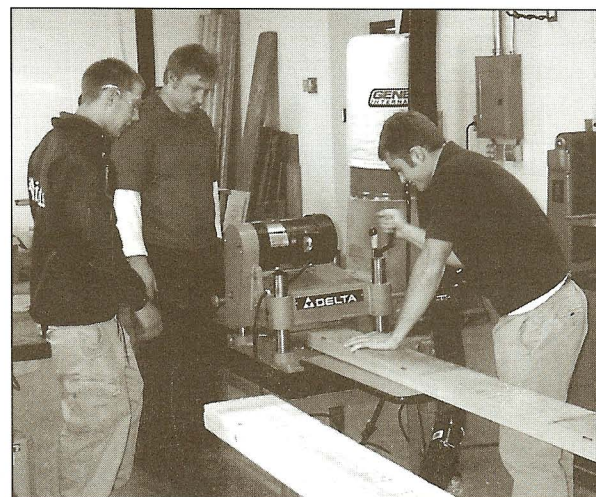


Dr. Ripperda in Haiti.

SHOP CLASS MOVES IN NEW DIRECTION WITH *OPTIONS 2006*

Throughout the 2004-2005 school year, the Mater Dei community participated in a comprehensive strategic planning process which was highlighted by a weekend retreat in April 2005. Through this process, it was clear that Mater Dei needed to address a key element of its curriculum, namely, its vocational education program and its classroom space. Through the efforts of the Faculty Council, the vocational education department, and the principal's office, *Options 2006* was created. *Options 2006* was the vehicle that drove the new curriculum for the Shop program and gave families and friends of Mater Dei an opportunity to financially support a new and improved Shop program.

When the new band room was built as part of the capital campaign in 2004, the fifth wing band room was vacated and it was the hope of the administration that the vocational classes could be moved from the south end of the Hut to the fifth wing. As plans to move the Shop program were taking place, so, too, was a review of the Shop curriculum and at that time it was decided to initiate a more specialized



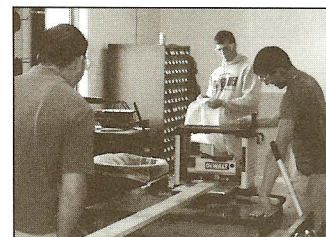
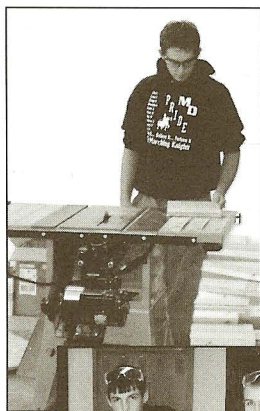
area and needed tools and equipment were purchased for the improved Shop program.

Contributing to the advancement of this project was the hiring of Jason Litteken, a 2001 Mater Dei graduate and 2005 SIU-Edwardsville graduate with a degree in Construction Management. In late July, Jason Litteken agreed to teach the newly structured Shop course on a part-time basis due to Alan Fuchs' decision to retire from teaching after 34 years. With the help of family and friends, Litteken transformed the old band room into a fully functional wood working shop that was newly equipped with adequate dust collection and ventilation, band

saw, thickness planer, jointer, spindle sander, miter saw, and large wooden work tables. A second set of doors was built inside the main hall entrance so the noise level would not affect the other classes in fifth wing.

According to the 2006-2007 curriculum guide, the Shop class is now designed to "educate the students on safe and proper usage of wood working tools while constructing a planned and organized project." The goals set for the class are to identify proper safety equipment and guidelines for the wood shop and finish room, to identify all of the wood working tools as well as their safety features and proper operating techniques, to educate the students to plan, organize, construct, and complete a project.

Mater Dei is committed to maintaining a "comprehensive" curriculum, one in which the diverse interests of all Mater Dei students is addressed. With the efforts of the Mater Dei administration and school board, and the financial support of the generous donors of *Options 2006*, the vocational education program at Mater Dei continues to meet the needs of the students.



program. The committee decided to create a wood working curriculum and transform the fifth wing space into a wood shop. Before this could happen, however, there were a few issues that needed to be addressed, such as ventilation, wiring, safety concerns, dust collection, and sound control. With the funds from *Options 2006*, these modifications were made to the classroom

Mr. and Mrs. James R. Lampe have recently endowed four scholarships for students from the Germantown-Bartleso-Breese area. These scholarships will be based on financial need and will be awarded each May. The Lampe Scholarship Program will be an annual scholarship with criteria that will be used for incoming freshmen.

Both Mr. Litteken and Mr. Lampe are members of the

Mater Dei Hall of Honor.

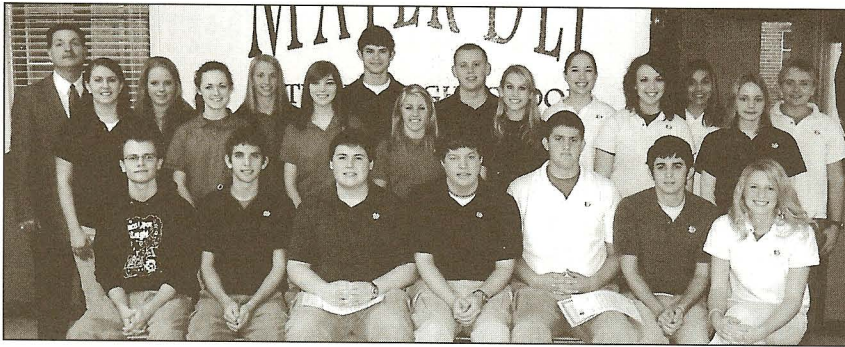

Did you know...

that the Mater Dei Class of 2007 has 21 Illinois State Scholars? That number represents 17% of the senior class. (The state average is 10% of a class). Selection for this honor is based on a combination of a student's ACT and/or SAT test score(s) and class rank at the end of his or her junior year.

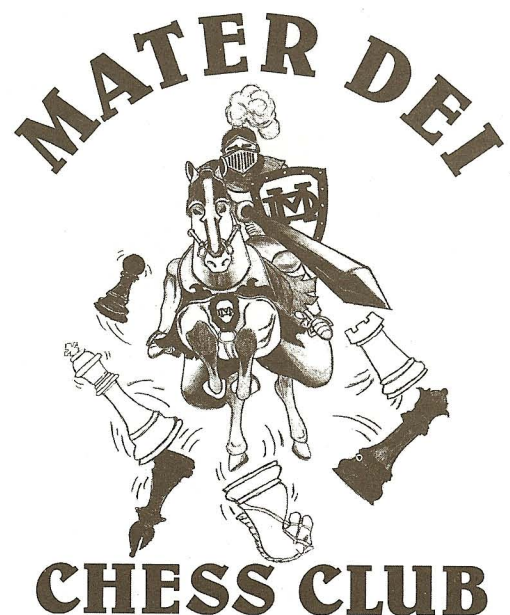
The IRA Charitable Rollover

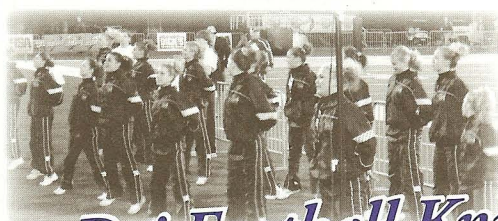

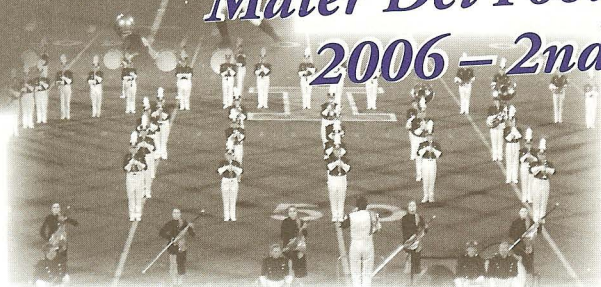
Did you know...
