The Strategic Plan Process

To plan for Mater Dei Catholic High School's future, the school community came together and established six committees to review, research, and plan on behalf of the students of Mater

Dei. These committees were staffed by volunteers, faculty members, administrators and students of Mater Dei. This process began in the winter of 2009 with committee members coming together on November 21, 2009, to identify areas of improvement and set goals to address these areas. The strategic retreat was facilitated by Sr. Ann Marie Bonvie, a 1966 graduate of Mater Dei and a member of the School Sisters of Notre


Out of the strategic retreat came a list of needs and strategies to be addressed to build upon our traditions and bring new opportunities to ensure that this school will continue to be a foundation of faith formation and academic excellence while remaining financially sound now and in the future. These needs were reviewed by the administration and school board and through this review a strategic plan was formed by the way of developing goals, action plans, and time

lines to address these issues in a timely fashion. The plan focuses on the next five years, but it establishes a vision that will extend well into the future. The strategic plan is visionary, mission driven, realistic, and comprehensive, while keeping the students' needs and dreams in mind.

In a proactive effort to effectively plan for the future of Mater Dei Catholic High School, the administration and school board present in this issue of the *VITA* their Strategic Plan. It serves as our guide to provide quality Catholic education for all those families who desire to pass on their faith and the

faith of the Catholic church to their children and their children's children.

We hope you share our excitement about the challenges and



opportunities for the future. Without you, we will not be able to continue to grow in faith and love for the future.

The Strategic Plan - Our Plan for the Road Ahead

As our plans for the future shape up, it is important for us to share our vision with you. The Mater Dei school board gave its approval to pursue the following components of the strategic plan and to research the community's level of support for such plans.

Creation of Student Center from Cafeteria and Patio - Students currently gather for meals and meetings in a tired, dark, dated, crowded noisy room. We envision expanding the current space into the existing patio resulting in a beautiful, bright, energy efficient, contemporary student center, with technology equipment and software, much like a cyber café, where students will gather comfortably at round tables for meals, meetings, social interaction, and various extra-curricular activities. This new attractive space with adjoining updated kitchen facilities will also lend itself to gatherings of alumni, parents, and friends of the Mater Dei community.

Campus Master Plan for Ongoing Facility Needs and Beautification – With the passing of time and changing

seasons, our buildings and surrounding grounds require ongoing attention. Roof replacements, sidewalk, curbing, and exterior door improvements are needed to assure our outside reflects the excellence and quality educational experience that occurs every day inside the classrooms and halls of Mater Dei. Besides the immediate needs, we plan to develop a campus master plan designed to systematically address these types of needs annually.

Outdoor Athletic Facilities - While we continue to invest in repairs and attempt to keep the athletic field, stands, and restrooms in good condition, the passage of time and conditions resulting from extensive use by our football team, boys' and girls' soccer teams, track teams, marching band, intramurals, and others demand that we address these facilities in a comprehensive manner. We envision the replacement of the outside fences, front gates, playing surface, grandstands, and renovation of the restrooms. This will result in a facility that is safe, competitive, and attractive and will be an incentive for prospective students and a source of pride for the entire Mater Dei community.

Technology Support and Equipment – Shifts in technology equipment and software for educational purposes present a continual, costly challenge that must be met to make certain our students are well

prepared for the future at the colleges and careers of their choice. In this strategic plan, our vision is to have new technology sources that would be incorporated into the creation of the Student Center, such as wireless areas and upgrades to the network, and to have the highest level of technology support and education possible.

The Next Step

With the Strategic Plan in mind, the Mater Dei School Board has approved conducting a feasibility study, and the school has engaged the services of Partners' in Mission to direct the study. The purpose of the feasibility interviews is to learn the level of support the community has for our plan and vision. If you are interested in being part of this study, please call the Mater Dei office. Interviews will be scheduled for sometime after the first of the year.

As Mater Dei Catholic High School continues to grow in its proud tradition linking the past with living the present in anticipation of the future, now is the time to recognize and respond to the call for vision, leadership, and renewed commitment to the mission of Mater Dei Catholic High School. It is the vision and mission that we invite all of you to share and embrace with us.

MATER DEI STUDENTS EXCEL ON ACT

The Mater Dei Class of 2010's average ACT test score not only exceeds the state average, but is also the highest average for a Mater Dei class in the past 20 years. With a composite average of 23.3, the Class of 2010 outscored the state average (20.5) by almost three points!

Students in the Class of 2010 scored above the state average on all four tests:




FRED RAKERS RETIRES FROM COACHING
